2. Performance

- The Performer agrees to provide a live performance of approximately **ten** minutes.
 - The Performer agrees to arrive on time and be ready for their scheduled performance slot.
 - The Performer will provide a list of any special technical or equipment requirements at least **7-10** days before the event.

3. Compensation

- This is a free, community-based talent show, and no financial compensation will be provided to performers.
 - Performers are not required to pay any entry fee. However, because this is a fundraising event, they are recommended to make a **voluntary “donate what you can” contribution** to help support the event and our cause to uplift lesser privileged youth. This donation is optional and will not strongly affect selection, scheduling, or participation in the show.
 - All participants will receive non-monetary recognition, which may a certificate of participation, if requested, or promotional features on event materials or social media.
 - Donations can be made in-person at the event before or after the performance in a donation box.
 - We ask that if you are sure you are going to make a donation, to give details in your application process.

4. Equipment and Setup

- The Organizer will provide the following equipment: the environment and possibly speakers and a microphone.
 - Performers are encouraged to bring their own equipment to ensure they have everything necessary for their setup.
 - Any additional technical requirements must be communicated in advance and approved by the Organizer. It is not guaranteed that the Organizers will provide all technical requirements for the all performers.

5. Cancellation

- If the Performer cancels less than five days before the event, the Performer agrees to forfeit any deposit and/or pay a cancellation fee of \$15.

6. Conduct

- The Performer agrees to behave professionally and respectfully toward the Organizer, staff, other performers, and attendees.
 - The Organizer reserves the right to remove any Performer who engages in inappropriate or disruptive behavior.
